## INSPECTION FEES

Code of Alabama, 1975, Section 34-13-111(b) and Administrative Code 395-X-4-.02 states that the Board shall charge a fee of \$75 for each annual inspection conducted. Said fees shall be submitted to the Board within 45 days of the inspection. **Inspection fees that are not received by the board within 45 days shall be charged a late penalty of \$150.**
