Anyone who has not renewed their funeral establishment, funeral director, embalmer or practical embalmer license, may still do so with a \$50.00 late penalty until March 31, 2013. If you failed to submit your paperwork and fee, including late penalty, for renewal by the March 31st deadline, the license(s) will be considered lapsed. At which time the establishment (s) or individual must cease operations and or practice. Any paperwork and fees received after the March 31st deadline, must go before the Board for reactivation approval.
