## **STATE LAW EXAM**

The 20 question state law exam given quarterly in Montgomery, AL will be given in a different format beginning with the January 6, 2014 exam. Previously the exam question format consisted of 7 multiple choice, 7 true or false, and 6 short answers. Beginning January 6, 2014, the state law exam will consist of **50 multiple choice questions**. There will **not** be any true /false or short answer questions on the exam. The study guide located on the Board's website will remain fill in the blank.

The Board voted to not allow cell phones to be brought into the testing room and not to permit anyone to leave and re-enter the testing room while the exam is being administer.

## ***The Conference***

As stated in previous notices, the funeral director and embalmer exams will be given by The Conference through Pearson VUE testing centers at five locations statewide. All applications may be obtained from our office. The exam fees and applications are to be submitted by the applicant to The Conference. The state license fees, applications, and affidavits shall be submitted to the Board office. Each applicant still must pass the state law exam given by the Board quarterly in Montgomery before being approved for licensing.
