THE LAW

Legislation was proposed, in the form of Senate Bill 94 and House Bill 88, during this year's regular annual sessions of legislators to amended an make significant changes to the Alabama Funeral Service Law. On June 2, 2011, Senate Bill 94 passed the House of Representatives and was sent to the Governor to be signed into law. Once signed by the Governor, the laws will become effective on October 1, 2011. More information will be made available in the coming months.
